Background:

STANDARD BANK BUREAU DE CHANGE will run a customer promotion targeting new and existing Bureau de Change (BDC) customers who transfer money through the BDC (with the minimum amount being US\$2,000 or its equivalent in other foreign currency). This promotion is open to Standard Bank Diaspora Account holders and clients using any other Bank account who transfer the minimum amount through the BDC.

By participating in the promotion, the customer confirms to be bound by these terms and conditions.

1 Promotion mechanics

1.1. Standard Bank Bureau de Change customer participation

1.1.1. The promotion will run from 11th March 2024 to 31st May 2024. Draws will be conducted at the end of each month.

1.1.2. The promotion will be available to BDC transfer clients who meet the eligibility criteria detailed below only.

1.1.3. All the cash prizes will be paid to a designated Malawi Kwacha account.

2. Prize categories

2.1 Draws

Draws for monthly prizes will be conducted once per month at STANDARD BANK PLC Head Office, Capital City Lilongwe.

The grand prize will be drawn at the end of the promotion and all entries which have qualified for the monthly draws will be eligible for the draw. The winner will be selected through random draw at STANDARD BANK PLC Head Office, Capital City Lilongwe

2.2. Winners of the cash prizes will be notified by email and or telephone call within 2 working days of the draw.
